Pursuant to the terms and conditions of Section 26 of the Connecticut Model Entity Transactions Act (the "META"), this certificate of entity conversion provides for the conversion (the "Conversion") of SunDance Rehabilitation Corporation, a Connecticut corporation (the "Converting Entity"), into SunDance Rehabilitation, LLC, a Connecticut limited liability company (the "Converted Entity").

- 1) Conversion. At the Effective Date of the Conversion (as hereinafter defined), the Converting Entity will be converted into the Converted Entity and will continue its existence as a limited liability company under the laws of the State of Connecticut under the name "SunDance Rehabilitation, LLC." The existence of the Converting Entity as a corporation will thereupon cease.
- 2) Plan of Entity Conversion. As of the date hereof, a Plan of Entity Conversion (the "Plan") setting forth the terms of the Conversion has been approved pursuant to Sections 22 through 27 of the META.
- 3) Effective Date of the Conversion. The Conversion will become effective on January 30, 2015 (the "Effective Date of the Conversion").
- 4) Articles of Organization. The Articles of Organization of the Converted Entity are attached hereto as Exhibit A.

Articles of Organization of SunDance Rehabilitation, LLC

PLAN OF ENTITY CONVERSION
of
SUNDANCE REHABILITATION CORPORATION,
a Connecticut corporation
into
SUNDANCE REHABILITATION, LLC,
a Connecticut limited liability company

Pursuant to the terms and conditions of Section 22 through 27 of the Connecticut Model Entity Transactions Act, this plan of entity conversion (this "Plan") provides for the conversion (the "Conversion") of SunDance Rehabilitation Corporation, a Connecticut corporation (the "Converting Entity"), into SunDance Rehabilitation, LLC, a Connecticut limited liability company (the "Converted Entity").

- 1) Conversion. At the Effective Time of the Conversion (as hereinafter defined), the Converting Entity will be converted into the Converted Entity and will continue its existence as a limited liability company under the laws of the State of Connecticut under the name "SunDance Rehabilitation, LLC." The existence of the Converting Entity as a corporation will thereupon cease.
- 2) Terms and Conditions of the Conversion. The terms and conditions of the Conversion (in addition to those set forth elsewhere in this Plan of Entity Conversion) are as follows:
 - a) Effect of the Conversion. At the Effective Time of the Conversion:
 - i) the Converting Entity will be converted into a limited liability company and will continue its existence as the Converted Entity;
 - ii) the existence of the Converting Entity as a corporation will cease;
 - iii) the Converted Entity will possess all the rights, privileges, immunities and franchises, of a public nature or of a private nature, of the Converting Entity;
 - iv) all property, real, personal and mixed, and all debts due on whatever account, and all other choses in action, and all and every other interest, of or belonging to or due to the Converting Entity, will be vested in the Converted Entity without further act or deed, and without any transfer or assignment having occurred, but subject to any existing liens thereon;
 - v) title to any real estate, or any interest therein vested in the Converting Entity will not revert or be in any way impaired by reason of the Conversion;
 - vi) all liabilities and obligations of the Converting Entity will be liabilities and obligations of the Converted Entity, which will, from and after the Effective Time of the Conversion, be the primary obligor therefor;

- vii) any claim existing or action or proceeding pending by or against the Converting Entity may be continued or prosecuted against the Converted Entity as if the Conversion had not occurred, and any judgment rendered against the Converting Entity may be enforced against the Converted Entity; and
 - viii) neither the rights of creditors nor any liens upon the property of the Converting Entity will be impaired by the Conversion.
- b) Articles of Organization and Limited Liability Company Agreement. From and after the Effective Time of the Conversion, the Articles of Organization as attached hereto as Exhibit A and the Limited Liability Company Agreement of the Converted Entity (which may be amended as provided therein in conformity with applicable law) will be the governing documents of the Converted Entity, and the Certificate of Formation and Bylaws of the Converting Entity will be of no further force and effect.
 - c) Manner and Basis of Conversion of Corporation Interests. At the Effective Time of the Conversion, all of the shares of common stock of the Converting Entity outstanding immediately prior to the Effective Time of the Conversion will, by virtue of the Conversion and without any action on the part of the Converting Entity or the Converted Entity, become all of the membership interests in the Converted Entity owned in the same percentages by the same owners as in the Converting Entity.
- 3) Other Provisions with Respect to the Conversion.
- a) Termination. This Plan of Conversion may be terminated at any time prior to the Effective Time of the Conversion, by action of the sole shareholder of the Converting Entity.
 - b) Amendment; Interpretation. The Converting Entity, by the consent of its sole shareholder, to the extent permitted by law, may amend, modify, supplement and interpret this Plan of Entity Conversion, and, in the case of an interpretation, the actions of such shareholder, will be binding.
- 4) Effective Time of the Conversion. The Conversion will become effective at the day and time set forth in the Certificate of Conversion to be filed with the Secretary of State of the State of Connecticut. As used herein, the term "Effective Time of the Conversion" refers to the time and date when the Conversion becomes so effective under the laws of the State of Connecticut.

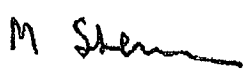
