TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is made this ___ day of June 2016 (the "Effective Date"), by and between CareerBuilder, LLC, a Delaware limited liability company having an address of 200 North LaSalle Street, Suite 1100, Chicago, IL 60601 ("Assignee") and Talent Stream LLC, an Ohio limited liability company having an address of 67 North Hayden Parkway, Hudson, OH 44236 ("Assignor").

WHEREAS, Assignor uses the mark TALENTSTREAM (the "Mark") in connection with employment hiring, recruiting, placement, staffing and career networking services ;

WHEREAS, on March 31, 2016, Assignor filed U.S. Trademark Application Ser. No. 86/959,824 to register the Mark in connection with such services (the "Application"); and

WHEREAS, June ___, 2016, Assignee and Assignor entered into an agreement under which Assignor agreed to convey all of its rights and goodwill in the Mark and the Application to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

1. Assignor does hereby assign, convey and transfer to Assignee, its successors, assigns and legal representatives, the full and entire right and interest in the United States in and to the following property:

- (i) the Mark;
- (ii) the Application;
- (iii) all of the trademark rights in the Mark under the laws of the United States, including all rights granted under 15 U.S.C. §1051, *et. seq.* (collectively, the "Trademark Rights");
- (iv) the right to claim the Trademark Rights and to obtain registrations therefor in the sole name of Assignee under the trademark laws of the United States; and
- (v) all causes of action for, and claims for damages by reason of, any infringement of the Trademark Rights, which causes of action and claims arose prior to the date of execution hereof.


