RELEASE OF SECURITY INTEREST

Recitals

WHEREAS, Grantor granted to Lender a security interest in certain intellectual property, including without limitation, the copyrights, patents and trademark items listed on Exhibits A, B and C attached hereto, respectively (collectively, the "Intellectual Property"), under (i) an Intellectual Property Security Agreement dated as of November 7, 2014 made by CRS in favor of the Lender which was recorded with the United States Patent and Trademark Office on November 10, 2014 at Reel 5398 and Frame 0791 and (ii) an Intellectual Property Security Agreement dated as of November 7, 2014 made by Motus in favor of the Lender which was recorded with the United States Patent and Trademark Office on September 19, 2015 at Reel 5626 and Frame 0562 (collectively, the "Security Agreement")

WHEREAS Grantor has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.

NOW THEREFORE, Lender agrees that it terminates and releases its security interest in the Intellectual Property and reconveys to Motus, without warranty or recourse, all interest of Lender in the Intellectual Property.
