CERTIFICATE OF MERGER

Pursuant to the Kansas General Corporation Code, the undersigned corporations certify the following:

1. The constituent corporations are: (a) **Wilbert Funeral Services, Inc.**, an Illinois corporation ("Wilbert"); and (b) **WFSI, Inc.**, a Kansas corporation ("WFSI").

2. An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to IBCA Chapt. 805 § 11.05 and KSA § 17-6702.

3. The surviving corporation is WFSI, Inc., a Kansas corporation, but the name of the surviving corporation shall be amended as set forth below.

4. The Articles of Incorporation of WFSI shall be the Articles of Incorporation of the surviving corporation, except that the Articles of Incorporation shall be amended as follows:

Article 1 shall be deleted in its entirety and replaced with the following:

"The name of the Corporation is Wilbert Funeral Services, Inc."

5. The executed plan of merger is on file at the principle place of business of the surviving corporation at 10965 Granada Lane, Suite 300, Overland Park, Kansas, 66211.

6. A copy of the plan of merger will be furnished by the surviving corporation, on request and without cost, to any shareholder.

7. The authorized capital stock of Wilbert consists of 1,000,000 authorized shares of voting common stock, \$0.001 par value per share, and 50,000 authorized shares of preferred stock, \$0.001 par value per share.
