RESTATED CERTIFICATE OF INCORPORATION OF

Puppet Labs, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

FIRST: That the name of this corporation is Puppet Labs, Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on April 22, 2009 under the name Reductive Labs, Inc.

SECOND: That at a meeting of the Board of Directors, the Board of Directors of this corporation adopted resolutions setting forth a proposed amendment to the Restated Certificate of Incorporation of this corporation, declaring said amendment to be advisable and in the best interests of this corporation and its stockholders and authorizing the appropriate officers of this corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment is substantially as follows:

RESOLVED, that Article I of the Restated Certificate of Incorporation of this corporation be amended and restated in its entirety to change the name of this corporation from Puppet Labs, Inc. to Puppet, Inc. and to read as follows:

"The name of this corporation is Puppet, Inc."

THIRD: That thereafter said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the stockholders holding the requisite number of shares required by statute given in accordance with and pursuant to Section 228 of the General Corporation Law of the State of Delaware.
