The parties to this agreement further agree that this assignment is to be recorded in all respective registers.

ASSIGNOR agrees to execute any papers or perform any acts required to establish, vest or protect ASSIGNEE's rights therein or required by ASSIGNEE to obtain said trademarks, without any additional payment therefor, but without any expense to ASSIGNOR.

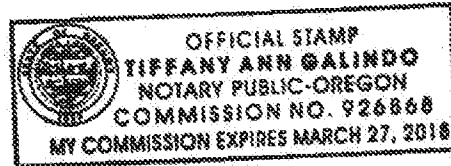
