**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of August 1, 2016, is made by Jefferies Finance LLC, in its capacity as collateral agent for the Secured Parties (in such capacity, together with any successor thereof, the "Collateral Agent"), pursuant to the Credit Agreement, dated as of May 22, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Security Agreement, dated as of May 22, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Security Agreement.

W I T N E S S E T H

WHEREAS, Blue Coat Systems, Inc., a Delaware corporation ("Blue Coat") and Elastica, Inc., a Delaware corporation ("Elastica") (collectively, the "Pledgors"), are parties to the Credit Agreement and the Security Agreement;

WHEREAS, pursuant to the Security Agreement, (i) Blue Coat executed the Grant of Security Interest in Trademark dated as of May 22, 2015 and recorded with the U.S. Patent and Trademark Office ("USPTO") on May 22, 2015 at Reel/Frame No. 5522/0106 and (ii) Elastica executed the Grant of Security Interest in Trademark dated as of November 16, 2015 and recorded with USPTO on November 16, 2015 at Reel/Frame No. 5669/0035 (collectively, the "Trademark Security Agreements"), pursuant to which the Pledgors pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties a Lien on and security interest in and to all of their right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreements);

WHEREAS, the Collateral Agent acknowledges the payment and performance of all the Obligations, and thus desires to terminate and release the security interest in the Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

1. Release of Lien. The Collateral Agent hereby terminates, without recourse, representation or warranty the Trademark Security Agreements, releases, without recourse, representation or warranty their security interest in all of the Collateral, and retransfers and reassigns to each Pledgor, as applicable, any right, title or interest of the Collateral Agent in, to or under the Collateral, including the trademark registrations and applications set forth in Schedule I, attached hereto and incorporated herein by reference.

2. Authorization to Record. The Collateral Agent authorizes and requests that the USPTO and any applicable government officer record this Release.


