INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of July 28, 2016 by and among **IJL ADVERTISING LLC**, a Nevada limited liability company ("**IJL-Ad**"), **IT'S JUST LUNCH INTERNATIONAL LLC**, a Nevada limited liability company (together with IJL-Ad, the "**Grantors**"), and **THL CREDIT, INC.**, a Delaware corporation (the "**Buyer**").

RECITALS

A. Buyer has agreed to purchase certain securities (the "**Investment**") from certain Affiliates of Grantors, It's Just Lunch International LLC, a Nevada limited liability company, IJL Everest, LLC, a Nevada limited liability company, IJL US LLC, a Nevada limited liability company, IJL NUS LLC, a Nevada limited liability company (together, the "**Sellers**") pursuant to that certain Securities Purchase Agreement by and among Buyer and Sellers dated of even date herewith (as the same may be amended, modified or supplemented from time to time the "**Securities Purchase Agreement**"). Capitalized terms used herein are used as defined in the Securities Purchase Agreement.

B. Each Grantor agrees that it will benefit from the purchase and sale of the securities by the Buyer, and IJL-Ad has entered into that certain Guaranty and Suretyship Agreement dated of even date herewith (the "**Guaranty**") in favor of the Buyer to guaranty payment and performance of the Obligations. As a condition to the purchase and sale of the securities, the Buyer required that Grantors enter into this Intellectual Property Security Agreement.

C. Pursuant to the terms of the Security Agreement entered into by each Grantor and the other grantors party thereto on the date hereof (the "**Security Agreement**"), each Grantor has granted to Buyer a security interest in all of such Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral, including without limitation, the Intellectual Property (as defined in the Security Agreement).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of the Guaranteed Obligations (as defined in the Guaranty), each Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure the Guaranteed Obligations, each Grantor grants and pledges to Buyer a security interest in all of such Grantor's right, title and interest in, to and under its Intellectual Property (including without limitation those registered copyrights, patents and trademarks listed on Exhibits A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

The security interests are granted in conjunction with the security interest granted to Buyer under the Security Agreement. The rights and remedies of Buyer with respect to the security interests granted hereby are in addition to those set forth in the Security Agreement and the other Investment Documents, and those which are now or hereafter available to Buyer as a matter of law or equity. Each right, power and remedy of Buyer provided for herein or in the Security Agreement or any of the Investment Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Buyer of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Security Agreement or any of the other Investment Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Buyer, of any or all other rights, powers or remedies.

Each Grantor represents and warrants that Exhibits A, B, and C attached hereto set forth any and all Intellectual Property rights in connection to which such Grantor has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

Each Grantor hereby acknowledges and agrees that Buyer may, from time to time and without notice to Grantors, amend Exhibits A, B and C hereto to reflect changes in such Grantor's right, title and interest in, to and under any copyrights, patents and trademarks; *provided* that each Grantor acknowledges and agree that Buyer's failure to so amend such Exhibits shall not limit or impair Buyer's security interest in any Intellectual Property.

The validity, interpretation and enforcement of this Intellectual Property Security Agreement and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by the laws of the State of New York.


