NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR's entire right, title and interest in, to and under the Marks, all registrations and applications for registration thereof, all rights derived from or associated with use of the Marks by ASSIGNOR together with the goodwill of the business symbolized by said Marks, and the right to recover for past infringement of said Marks and that portion of the business to which the Marks pertain for any pending U.S. trademark applications which as of the date hereof are "intent-to-use" applications, which business is ongoing and existing.

ASSIGNOR hereby covenants, warrants, and represents that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

This Assignment supersedes that assignment document executed January 5, 2016 by Assignor regarding the Marks.

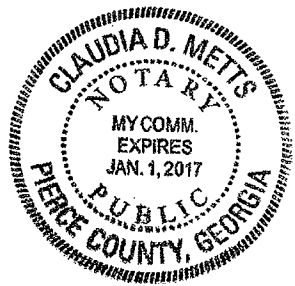
