RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of July 8, 2016 and granted by Barry Honig, as collateral agent for the secured party under the Security and Pledge Agreement referred to below (the "Secured Party"), in favor of Rant, Inc., a Delaware corporation (the "Grantor") and its successors, assigns and legal representatives.

WHEREAS, the Grantor, the Collateral Agent and the investors party thereto entered into that certain Security and Pledge Agreement dated as of December 14, 2015 (the "Agreement");

WHEREAS, pursuant to the Agreement, the Grantor pledged and granted to the Collateral Agent for the ratable benefit of the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office at Reel 005709, Frame 0821 on December 14, 2015; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent and the Secured Party may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Party, their successors, legal representatives and assigns, hereby terminates the Agreement with respect to the trademarks identified hereto on Schedule A (collectively, the "Trademark Collateral") and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to the Trademark Collateral. Collateral Agent hereby authorizes and requests the United States Patent and Trademark Office, and any other applicable government agency, to note and record the existence of such release hereby given.

2. Further Assurances. Collateral Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
