**NOTICE OF RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Notice of Release"), dated as of July 29, 2016, is made by **BANK OF AMERICA, N.A.**, in its capacity as Administrative Agent (the "Administrative Agent").

WHEREAS, PRINCETON PAYMENT SOLUTIONS, LLC (the "Grantor"), FINANCIAL TRANSACTION SERVICES, LLC (now known as CARDCONNECT, LLC) and the Administrative Agent entered into that certain Security and Pledge Agreement ("Security Agreement") dated as of July 12, 2012, whereby each Grantor granted to Administrative Agent a continuing security interest in all of its right, title and interest in all trademarks, including, without limitation, each trademark listed on Schedule A attached hereto (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the records of the Trademark Division of the U.S. Patent and Trademark Office on July 17, 2012 at Reel 4823/Frame 0013.

WHEREAS, the Administrative Agent has agreed to release its security interest in, and discharge fully its lien on, the Trademarks in accordance with the terms of the Security Agreement, and as herein provided.


NOW, THEREFORE, pursuant to the Security Agreement, and upon the terms set forth in this Notice of Release, the Administrative Agent hereby agrees as follows:

1. Release of Security Interest. For valuable consideration, the Administrative Agent hereby terminates, discharges and releases any and all mortgages, liens and security interest granted to the Administrative Agent in all of the Trademarks without representation, warranty or recourse of any kind, and any right, title or interest of the Administrative Agent in such Trademarks shall hereby cease and become void.
2. Authorization. Administrative Agent authorizes this Notice of Release to be recorded with the U.S. Patent and Trademark Office. Administrative Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of Administrative Agent's security interest in the Trademarks.
3. Governing Law. This Notice of Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
