## NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), effective as of July 29, 2016, is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Lender (in such capacity, the “**Lender**”), in favor of KSE SPORTSMAN HOLDINGS, LLC, a Delaware limited liability company (“**KSE Holding**”), SKYCAM, LLC, a Delaware limited liability company, THE OUTDOOR CHANNEL, INC., a Nevada corporation, a Delaware corporation, ALTITUDE SPORTS & ENTERTAINMENT, LLC (F/K/A KSE MEDIA VENTURES, LLC), a Colorado limited liability company, CABLECAM, LLC, a Delaware limited liability company, and WINNERCOMM, INC., a Delaware corporation (collectively, the “**Grantors**” and individually, each a “**Grantor**”).

WHEREAS, pursuant to that certain Security Agreement dated as of November 7, 2014 and recorded in the United States Patent and Trademark Office on December 11, 2014 at Reel: 005417 and Frame: 0893-0968 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “**Security Agreement**”) by and among the Grantors, Lender, and others party thereto, each Grantor, with the exception of KSE Holdings, mortgaged, pledged, and hypothecated to the Lender and granted to the Lender a Lien on and a security interest in, all of such Grantors’ right, title and interest in and to all of its Trademarks and Trademark Licenses, including without limitation the trademark registrations and applications listed on Schedule A hereto (“**Schedule A Trademarks**”), together with all renewals and extensions thereof, all goodwill of the business connected with the use of and symbolized by each such Trademark and Trademark License, and all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the “**Released Assets**”);

WHEREAS, that certain Trademark Assignment Cover Sheet recorded in the United States Patent and Trademark Office on December 11, 2014 at Reel: 005417 and Frame: 0893-0895 (“**Recorded Cover Sheet**”) identified the conveying parties, the receiving party, and the properties subject to the Security Agreement, and in particular identified KSE Holdings as one of the conveying parties of the Released Assets;

WHEREAS, the Lender wishes to provide a document suitable for recording in the United States Patent and Trademark Office the Lender’s release, relinquishment and discharge of all of Lender’s right, title and interest, including its security interest, in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender agrees as follows:

1. Ownership. The Grantors, other than KSE Holdings, are the sole owners of the Schedule A Trademarks. KSE Holdings did not and does not have any interest in the Schedule A Trademarks. The Recorded Cover Sheet wrongly indicates that KSE Holdings was a conveying party of the Schedule A Trademarks under the Security Agreement.

2. Release. Subject to paragraph 1, the Lender hereby relinquishes, releases and discharges its mortgage, pledge, and hypothecation and Lien on and security interest in the Released Assets and reassigns all of its right, title and interest in the Released Assets to the Grantors as set forth in Schedule A, without any representation, recourse or undertaking by Lender, wherein for any individual Released Asset, the relinquishment, release, discharge, and reassignment is made with respect to the specific owner identified in connection with that Released Asset as set forth in Schedule A.


3. Further Assurances. Lender or the Lender's authorized representatives shall have the right to record this Release with the United States Trademark Office. The Lender further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts which the Grantors (or their agents or designees) reasonably request (at the Grantors' sole cost and expense) in order to confirm this Release.


4. Governing Law. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

5. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.
