RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is made as of August 1, 2016 ("Effective Date") by BMO Harris Bank N.A. (successor in interest to M & I Marshall & Ilsley Bank) (the "Bank"), in favor of Hal Leonard LLC (successor to Hal Leonard Corporation formerly known as Hal Leonard Publishing Corporation), a Delaware limited liability company (the "Company").

WHEREAS, the Company previously granted a security interest in certain intellectual property of the Company to the Bank, which security interests were granted pursuant to (i) that certain Trademark and Copyright Security Agreement entered into as of June 12, 2000, and recorded with the United States Copyright Office as document number V3462D682 on December 15, 2000, by the Company in favor of the Bank; and (ii) certain documentation recorded with the United States Patent and Trademark Office at Reel 0911, Frame 0134 on October 26, 1992 and Reel 1095, Frame 0238 on January 14, 1994; and

WHEREAS, the Bank has agreed to release all security interests, liens and all other rights it has in and to the intellectual property of the Company, including, without limitation, the (a) copyrights listed on Exhibit A attached hereto; (b) patents listed on Exhibit B attached hereto; and (c) trademarks listed on Exhibit C attached hereto (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby releases all its rights in and to the Released Collateral, and reconveys to the persons legally entitled thereto all of the Bank's right, title and interest in and to the Released Collateral.


