## ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "Assignment of Trademarks") effective as of May 13, 2016, is entered into by and between RFaxis, Inc., a Delaware corporation ("Assignor"), and Skyworks Solutions, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of those certain trademarks set forth in the attached Schedule A (the "Marks");

WHEREAS, Assignor and certain of its affiliates and Assignee are parties to that certain Asset Purchase Agreement, dated as of May 4, 2016 (the "Purchase Agreement"); and

WHEREAS, pursuant to the Purchase Agreement, Assignee is acquiring from Assignor, and Assignor is transferring to Assignee all of Assignor's rights, title and interest in and to the Marks;

NOW THEREFORE, for good and valuable consideration as set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:

(i) Conveyance and Acceptance. Assignor hereby assigns, transfers and conveys to Assignee: Assignor's entire right, title and interest in and to the Marks throughout the world, the goodwill of the business associated with or symbolized by the Marks, all common law rights, trade name rights, registrations and applications for registration thereof, the right to sue, either at law or in equity, and the right to recover for any past, present or future infringements thereof and the right to initiate other proceedings before all government and administrative bodies with respect to the Marks.

(ii) Further Action. Assignor agrees to do all acts and take such further action, including the execution and acknowledgment of such additional documents as Assignee may reasonably request to carry out and fulfill the purposes and intent of this Assignment of Trademarks.

(iii) Recordation. Assignor authorizes and requests the Commissioner of Trademarks of the United States, and the corresponding entities or agencies in any country foreign to the United States, to record Assignee as the assignee and owner of record of the Marks issued in the United States or issued or registered in any corresponding jurisdiction.

(iv) Miscellaneous.

(a) This Assignment of Trademarks shall be binding upon and inure to the benefit of the parties hereto, and their permitted successors in interest and assigns.

(b) This Assignment of Trademarks will be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to any choice or conflict of law provision or rule that would cause the application of the laws of any other jurisdiction.

(c) This Assignment of Trademarks may be amended or modified only by a written instrument executed by all of the parties hereto.

(d) This Assignment of Trademarks may be executed in several counterparts, each of which will constitute an original and all of which, when taken together, will constitute one and the same agreement.

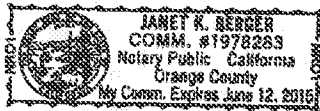


