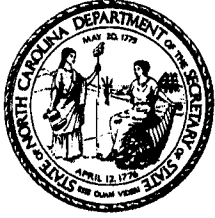

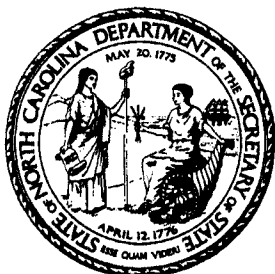


1. The name of the limited liability company is ARAP ACQUISITION, LLC.
