**NOTICE OF RELEASE OF SECURITY INTEREST**

This Notice of Release of Security Interest (the "Release") is effective as of August 4, 2016, by **BANK OF AMERICA, N.A. as successor in interest to FLEET NATIONAL BANK** (together with its successors, "Secured Party").

WHEREAS, reference is made to that certain Assignment of Security Interest in U.S. Trademarks dated as of September 20, 2004 by **LAURELWOOD HOLDING COMPANY**, a Pennsylvania corporation (the "Grantor"), in favor of Secured Party (the "Agreement"); and

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Agreement and the Security Agreement (as defined in the Agreement), Secured Party hereby releases, terminates, discharges and remits, without any recourse, representation or warranty, any and all security interests that it has in the Intellectual Property pursuant to the Agreement, the Security Agreement and any other agreement or document delivered in connection with the Security Agreement, including, without limitation, any and all rights, title and interests in and to the Intellectual Property, and hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.
