## RELEASE OF SECURITY INTERESTS

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of August   2  , 2016, is made by CAPITALSOUTH PARTNERS SBIC FUND III, L.P., a Delaware limited partnership, as administrative and collateral agent for the lenders ("Secured Party").

WHEREAS, MERLIN INTERNATIONAL, INC., a Colorado corporation ("Debtor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of December 15, 2014, (the "Agreement"), which was recorded with The United States Patent and Trademark Office on December 16, 2014, in its records at Reel 005420, Frame 0334; capitalized terms used herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Secured Party a security interest in all of Debtor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including, without limitation: (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all rights of Debtor as licensor, or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications; and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby (a) fully and finally releases and terminates any and all of Secured Party's right, title and interest in and to the Trademark Collateral and (b) authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.




