TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "**Termination and Release**") is granted as of June 30, 2016 by **SILICON VALLEY BANK**, as Administrative Agent (the "**Assignee**"), in favor of **LOANSIFTER, LLC**, a Delaware limited liability company ("**Loansifter**") and **OPTIMAL BLUE, LLC**, a Texas limited liability company ("**Optimal**", and together with Loansifter, individually, a "**Grantor**", and collectively, the "**Grantors**").

WHEREAS, Optimal executed and delivered and Trademark Security Agreement dated as of December 28, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**2012 Agreement**"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded Assignment Division of the United States Patent and Trademark Office ("**USPTO**") on December 28, 2012, at Reel 4932, Frame 0126;

WHEREAS, Loansifter executed and delivered and Trademark Security Agreement dated as of December 18, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**2013 Agreement**" and with the 2012 Agreement, collectively, the "**Grants**"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded Assignment Division of the United States Patent and Trademark Office ("**USPTO**") on December 20, 2013, at Reel 5179, Frame 0850;

WHEREAS, the Grantors have requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the trademarks and trademark applications described in the Agreement (collectively, the "**Marks**") as herein provided; and

WHEREAS, the Grantors have requested that the Assignee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in each of the Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those Marks identified in Schedule I hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to the Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
