**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 22, 2016 (“Release”), is made by Wells Fargo Bank, National Association (“Bank”) in favor of Jamba Juice Company, a California corporation (“Pledgor”).

WHEREAS, pursuant to that certain Security Agreement dated as of February 14, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Pledgor, Bank, and others party thereto, and the Grant of Security Interest in Trademarks dated as of February 14, 2012 and recorded at the United States Patent and Trademark Office (“USPTO”) on February 15, 2012 at Reel 4718 Frame 0238 (“IP Grant”) by and among Bank and Pledgor, Pledgor granted to the Bank a security interest in all of its right, title and interest in and to the Trademarks, and Trademark registrations, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks (collectively, “Trademark Collateral”); and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Grant.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to Pledgor’s right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or IP Grant; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.

IN WITNESS WHEREOF, the Bank has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
