TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") effective as of August 1, 2016 (the "Effective Date"), is made by and between AG Nouveaux, Inc., ("Assignor"), an Idaho corporation with an address at P.O. Box 7970, Ketchum, ID 83140; and Bogle Vineyards, Inc., ("Assignee"), a California corporation with an address at 49762 Hamilton Road, Clarksburg, CA 95612.

WHEREAS, Assignor is the owner of the U.S. trademark registration for PHANTOM HILL, U.S. Reg. No. 2,704,241, for "wine", together with the goodwill associated therewith, (the "Trademark"), as shown in Exhibit A; and

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign all of its right, title and interest in and to the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby sells, assigns and transfers to Assignee all of Assignor's worldwide right, title and interest in, to and under the Trademark together with the goodwill of the business associated therewith and which is symbolized thereby, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, any such payments resulting from past, present or future infringement or other unauthorized use of the Trademark, together with the right to sue for and collect the same.


Assignee grants Assignor a royalty-free license to use the Trademark on Assignor's existing inventory of fewer than 400 cases of wine.
