## TRADEMARK ASSIGNMENT

WHEREAS, Funtactix, Inc. a Delaware corporation, of P.O. Owner agrees to execute all documents, papers, forms, and authorizations and take all other action that may be necessary for securing, completing, or vesting in Purchaser and its successors, legal representatives, and assigns the full right, title, and interest in the Trademark and subsequent registration thereof.

3. Owner authorizes and requests any official of any country or jurisdiction, whose duty it is to issue and to record trademarks, to issue and record the Trademark to and in the name of the Purchaser, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.

4. Owner hereby irrevocably appoints the Purchaser and its duly authorized officers and agents as attorney in fact for Owner, to act on its behalf to execute and file any documents and to do all other lawfully permitted acts to further the purposes of this Assignment, with the same legal force and effect as if executed by the Owner.

5. This Assignment shall be binding upon and inure to the benefit of the parties hereto and any assigns, related companies, and the successors thereof.
