INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this “**Assignment**”) is executed as of this 31 day of July, 2016, by Healthways, Inc., a Delaware corporation, American Healthways Services, LLC, a Delaware limited liability company, Healthways International, Inc., a Delaware corporation, Healthways Hawaii, LLC, a Delaware limited liability company, Healthways Ornish, LLC, a Delaware limited liability company, Healthways International, S.a.r.l, an entity formed in Luxembourg, Clinical Decision Support, LLC, a Delaware limited liability company, Healthways Health Support, LLC, a Delaware limited liability company, Healthways QuitNet, LLC, a Delaware limited liability company, Healthways HealthTrends, LLC, a Delaware limited liability company, Ascentia Health Care Solutions, L.L.C., a Delaware limited liability company, Healthways WholeHealth Networks, Inc., a Delaware corporation, and Population Health Support, LLC, a Delaware limited liability company (each, an “**Assignor**” and collectively, the “**Assignors**”), and Healthways SC, LLC, a Delaware limited liability company (the “**Assignee**”).

RECITALS

WHEREAS, Assignors own certain trademarks, copyrights, patents, domain names, trade secrets, software (including source code), other copyrightable works and other intellectual property rights including, but not limited to, those described in Annex A attached hereto and made a part hereof;

WHEREAS, Assignors and Assignee have entered into that certain Contribution and Assumption Agreement dated as of the date hereof, by and among the Assignors, the Assignee, and the other signatories thereto (the “**Contribution and Assumption Agreement**”), pursuant to which Assignors are selling, assigning, transferring and delivering to Assignee the Contributed Assets (as defined in the Contribution and Assumption Agreement), including the Transferred IP (as defined in the Contribution and Assumption Agreement), all as more particularly described in the Contribution and Assumption Agreement; and

WHEREAS, pursuant to the terms of the Contribution and Assumption Agreement, Assignee desires to acquire and accept from each Assignor such Assignor’s right, title and interest in and to the Transferred IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and with the intention of being legally bound hereby, the Assignor hereby agrees as follows:

1. ASSIGNMENT. Each Assignor does hereby sell, assign, transfer and set over unto Assignee all of such Assignor’s right, title and interest in and to the Transferred IP, including the Transferred IP as described in Annex A, hereto and including: (a) all rights in and to any of the foregoing, including the right to sue, recover damage, costs, and attorneys' fees for past and present infringement or misappropriation of any of the foregoing; and (b) all rights corresponding thereto throughout the world, as fully and entirely as the same would have been held and enjoyed by such Assignor had this Assignment and sale not been made.

2. TRANSFER DOCUMENTS; FURTHER ASSURANCES. Assignor further agrees that, when requested, Assignor will, without demanding any further consideration therefor, do all lawful and just acts, including the execution and acknowledgement of instruments, that may be or become reasonably necessary for maintaining and perfecting Assignee's right to the Transferred IP and to render all reasonably necessary assistance in making application for and obtaining registration of the Transferred IP with the U.S. Patent and Trademark Office or U.S. Copyright Office or of any and all foreign countries, and in enforcing any rights in any action accruing as a result of such applications or the Transferred IP, by giving testimony in any proceedings or transactions involving such applications or the Transferred IP, and by executing preliminary statements or other affidavits, it being understood that this Assignment and the foregoing covenants and agreements shall bind, and shall inure to the benefit of, the respective successors, assigns and legal representatives of each Assignor and Assignee.

3. GOVERNING LAW. This Assignment shall be construed in accordance with and governed by the laws of the State of Delaware (excluding all other choice of law and conflicts of law rules).




