## CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY TRADEMARK ASSIGNMENT (this "Assignment") is made and entered by and between **NOV TV2 LLC**, a Delaware limited liability company doing business at 7909 Parkwood Circle Drive, Houston, TX 77036 ("Assignor") and **Grant Prideco, Inc.**, a Delaware corporation doing business at 7909 Parkwood Circle Drive, Houston, Texas 77036 ("Assignee"). Assignor and Assignee agree that this Assignment is made effective as of November 9, 2015 ("Effective Date").

WHEREAS, Assignor and Assignee are parties to that certain Distribution Agreement dated November 9, 2015 (the "Distribution Agreement"), pursuant to which Assignor distributed, transferred, conveyed, assigned and delivered all its right, title and interest in and to the Transferred Intellectual Property to Assignee, including trademarks as more specifically set forth in the attached Appendix A (the "Trademarks"). Capitalized terms not otherwise defined herein have the meaning as set forth in the Distribution Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, Assignor does hereby distribute, transfer, convey, assign and deliver to Assignee, its successors and assigns, all rights, title, and interest in and to the Trademarks, together with the goodwill of Assignor's business in connection therewith, and the full right to sue for past, present or future infringement of any of such Trademarks, and possession and worldwide use of all the Trademarks currently owned or used by Assignor, these rights to be held and enjoyed by Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by the Assignor had this assignment not been made, including but not limited to, all registration rights with respect to the Trademarks, and the right of claiming for itself the priority of filing of applications for the registration of the Trademarks in other countries, in accordance with Article 4 of the International Paris Convention, and any other applicable convention and/or treaty.

Assignor hereby authorizes and directs the appropriate governmental officials to record this Assignment and any information relating thereto upon the request of Assignee, and to issue any and all such related property right assigned hereunder to Assignee, as the owner of the entire and exclusive right, title, and interest in and to the same.

Assignor further covenants and agrees, for itself, its directors, officers, employees, and subcontractors, to execute and deliver without further consideration, any and all other instruments in writing, including further applications, papers, affidavits, powers of attorney, assignments, and other documents, and do all lawful acts and things, which, in the opinion of counsel for Assignee, may be required or necessary to more effectively secure and vest in Assignee, its successors, and permitted assigns the rights transferred hereunder, and that Assignor will sign any counterpart, renewal, or extension of said rights transferred hereunder or any related property right.

Assignor represents and warrants that it has full authority to execute this Assignment and that the rights granted in the Trademarks are free and clear of any encumbrances to the best of Assignor's knowledge.

This Assignment and performance hereunder shall be governed by and construed in accordance with the laws of the State of Texas without giving effect to any choice or conflict of law provisions. Any and all proceedings relating to the subject matter hereof shall be maintained in the courts of the State of Texas or the federal district courts sitting in Texas, which courts shall have exclusive jurisdiction for such purpose. If any provision of this Assignment shall be held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall in no way be affected or impaired thereby. All amendments and other modifications hereof shall be in writing and signed by the parties hereto. The failure of either party to exercise in any respect any right provided for herein shall not be deemed a waiver of any right hereunder.

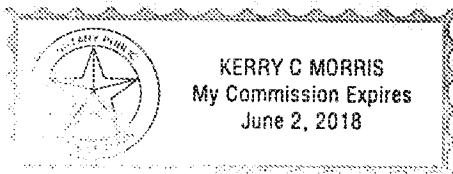

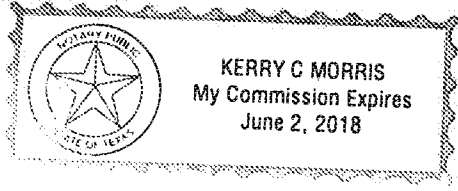
