TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), dated effective as of July 22, 2016 (the "Effective Date"), is by and between Robin Christopher Colclough, an individual who resides at 20-22 Wenlock Road, London N1 7GU GB and Camino de Ca Na Gallura 2A, Establiments, Palma de Mallorca 07010 Spain, and who is a citizen of the United Kingdom doing business in the United States of America ("Colclough"), OWNTV Group, a trading group located at 20-22 Wenlock Road, London N1 7GU GB ("OWNTV Group"), and Viewpoint 3D, located at 20-22 Wenlock Road, London N1 7GU GB ("Viewpoint"), on the one side (Colclough, OWNTV Group, and Viewpoint are sometimes referred to herein collectively as "Assignor") and OWN LLC, a Delaware limited liability company located at 1041 N. Formosa Avenue, West Hollywood California 90046 ("Assignee"). Assignor and Assignee are sometimes referred to herein each as a "Party" or together as the "Parties."

A. Assignor has adopted, and is, to the best of his/its knowledge and belief, the owner of the trademark OWNTV®, and U.S. Registration No. 4,825,764 and EU TM Reg. No. 5121017, and all other rights appurtenant thereto, including, without limitation, all common law rights, trade name rights, domain name rights, causes of action, and the right to recover for past infringement (the "Trademark").

B. Assignor has acquired goodwill in the portion of the business associated with and symbolized by the Trademark and has not abandoned same.

C. Assignor desires to assign to Assignee all rights, titles, and interests in and to the Trademark owned by Assignor. re

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

(1) Assignor hereby conveys, sells, transfers and assigns to Assignee all of Assignor's past, present, and future rights, titles, and interests throughout the universe in and to (a) the name and mark "OWNTV," (b) United States Trademark Registration 4,825,764, (c) EU TM Reg. No. 5121017, and (d) all goodwill of the business(es) connected with the use of and symbolized by any and all of the Trademark, together with (i) all income and royalties hereafter due or payable to Assignor with respect to the Trademark, (ii) all damages and payments for past or future infringements and misappropriations of the Trademark; and (iii) all rights to sue for past, present and future infringements, dilutions, misappropriations, and/or unfair competitions of the Trademark, all for Assignee's own use and enjoyment (including, without limitation, the right to renew and/or apply for trademark and/or service mark registrations within or outside the United States based in whole or in part upon the Trademark, and including any priority right that may have arisen from Assignor's use of the Trademark and/or prior ownership of the registrations thereto).




