**CERTIFICATE OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF  
MACULAR HEALTH, LLC**  
*(Changing its name to Lunovus, LLC)*

Pursuant to the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code, the undersigned hereby adopts the following amendment to its Articles of Organization:

**ONE:** The name of the company is Macular Health, LLC (the "Company").

**TWO:** The Company's Alabama Entity ID Number is 694-562.

**THREE:** The Company filed its Articles of Organization with the Judge of Probate of Jefferson County, Alabama, on October 31, 2003.

**FOUR:** This Amendment has been approved in the manner required by the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code and the Governing Documents of the Company.

**FIVE:** The Company's Articles of Organization are hereby amended as follows:

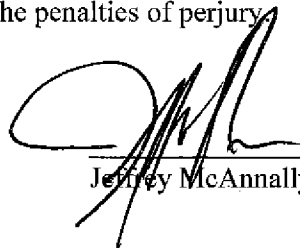
Article I is hereby deleted in its entirety, and the following is substituted in lieu thereof:
