RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release is intended to operate as a release of all liens and security interests conveyed by each Company to Lender pursuant to the terms of the Trademark Agreement, without any representation, warranty or undertaking by, or recourse to, Lender. If and to the extent Lender has acquired any right, title or interest in and to any of the Trademark Collateral pursuant to the terms of the Trademark Agreement, Lender hereby reassigns and transfers such right, title and interest to each Company, together with the goodwill of each Company's business connected with and symbolized by the Trademark Collateral, without any representation, warranty or undertaking by, or recourse to, Lender.
