**RELEASE OF JUNIOR LIEN INTELLECTUAL PROPERTY SECURITY  
AGREEMENT**

This Release of Junior Lien Intellectual Property Security Agreement (this "Release") is made as of August 9, 2016, by Royal Bank of Canada, a chartered bank of Canada, in its capacity as administrative agent and collateral agent (together with its successors in such capacity, the "Administrative Agent") for the benefit of Home Acres Building Supply Co. LLC, a Michigan limited liability company, Great Western Building Materials, Inc., an Arizona corporation, and ProWall Building Products, Inc., an Arizona corporation (the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the IP Security Agreement.

W I T N E S S E T H:

WHEREAS, reference is made to that certain (i) Junior Lien Term Loan Credit Agreement, dated as of October 9, 2015, among LSF9 Cypress Parent LLC and LSF9 Cypress Holdings LLC in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "Credit Agreement"); (ii) Junior Lien Guarantee and Collateral Agreement, dated as of October 9, 2015 in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, (the "Guarantee and Collateral Agreement"); and (iii) Junior Lien Intellectual Property Security Agreement, dated as of October 9, 2015, among Grantors in favor of Administrative Agent ("IP Security Agreement") pursuant to which the Grantors have granted to the Administrative Agent for its benefit and the benefit of various other financial institutions, a security interest in the intellectual property set forth on Schedules 1, 2 and 3 hereto (the "IP") and the goodwill of the business symbolized by such IP, and the registrations and applications therefor (together with the IP, the "IP Collateral");

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on December 21, 2015 at Reel 5694 and Frame 0619 for trademarks and at Reel 37358 and Frame 273 for patents; and

WHEREAS, Grantors have requested that the Administrative Agent release, and the Administrative Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. The Administrative Agent does hereby terminate, release and discharge the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the IP Security Agreement to the IP Collateral and any right, title or interest of the Administrative Agent in such IP Collateral shall hereby terminate, cease and become void. The Administrative Agent hereby assigns, transfers and conveys any and all right, title or interest of the Administrative Agent in the IP Collateral to the Grantors.

2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be


deemed an original, but all such counterparts together shall constitute but one and the same instrument.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
