All rights in or to the Mark, including, without limitation, the right to sue for any damages and other remedies in respect of any infringement of the Mark which may occur after the date of this Assignment, shall be the sole property of Assignee and inure to the benefit of Assignee.

Successors and Assigns. This Agreement shall inure to the benefit of and be binding upon Assignor and its respective heirs, successors, licensees and assigns.
