RELEASE OF SECURITY INTEREST IN TRADEMARKS



Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Subject Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of New York.


