TRADEMARK ASSIGNMENT

Each Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Marks and all prior use rights to the Marks.

This Assignment of the Marks is made pursuant to (and does not modify) the Asset Purchase Agreement, which contains certain representations, warranties and covenants regarding the Marks and in the event of any conflict or other inconsistency between this Assignment and the Asset Purchase Agreement, the Asset Purchase Agreement shall govern and be the controlling document.

This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York regardless of any laws that might otherwise govern under applicable principles of conflicts of laws thereunder. This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.




