TERMINATION OF SECURITY INTEREST IN TRADEMARK

This **TERMINATION OF SECURITY INTEREST IN TRADEMARK**, dated as of June 29, 2016, is made pursuant to the Trademark Security Agreement dated as of August 9, 2012 ("Security Agreement") by and among Crescent Resources, LLC, a Georgia limited company ("Borrower"), Crescent Holdings, LLC, a Delaware limited liability company ("Holdings"), and the Original Guarantors (as defined in the Security Agreement)(the Original Guarantors, Borrower and Holdings each a "Pledgor" and collectively, the "Pledgors") and Wilmington Trust, National Association, as collateral agent, (the "Grantee") (in such capacity and together with any successors in such capacity, the "Parity Collateral Trustee") for the Secured Parties referenced therein.

WHEREAS, the Pledgors pledged and granted to the Parity Collateral Trustee for the ratable benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under certain Trademark Collateral (as defined in the Security Agreement), including the Trademark identified on Schedule A attached hereto, the Goodwill associated with such Trademark and all Proceeds of any and all of the foregoing attributable to such Trademark;

WHEREAS, the security interest granted to the Secured Parties was recorded at the United States Patent and Trademark Office on August 9, 2012, at Reel 4839 and Frame 0833; and

NOW, THEREFORE, for valuable consideration, the Parity Collateral Trustee hereby terminates and releases all mortgages, liens, and security interests granted to it under the Security Agreement in the following Trademark:

1. The Trademark identified on Schedule A attached hereto.
