**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of August 9, 2016, by JEFFERIES FINANCE LLC, a Delaware a limited liability company (the “Collateral Agent”).

W I T N E S S E T H:

WHEREAS, STOWE WOODWARD LICENSCO LLC, a Delaware limited liability company with an 14101 Capital Blvd., Youngsville, North Carolina 27596 (the “Grantor”), entered into a certain trademark security agreement dated May 17, 2013 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on May 17, 2013 at the United States Patent and Trademark Office at Reel 5030, Frame 0699.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to certain of Grantor’s intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
