TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is entered into as of May 31, 2016 by and between Open Mobile Alliance Limited, a company organized under the laws of England and Wales and limited by guarantee ("ASSIGNOR"), and Open Mobile Alliance, a California nonprofit mutual benefit corporation ("ASSIGNEE").

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest in and to the Marks (including, without limitation, all applications, registrations and registration renewals pertaining thereto), together with (1) all goodwill of the business associated therewith; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks. ASSIGNOR acknowledges that it intends by this Agreement to assign to ASSIGNEE all of its right, title and interest in the Marks worldwide.


ACKNOWLEDGMENT AND ACCEPTANCE


