RELEASE OF FIRST LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF FIRST LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of August 12, 2016 (the “Effective Date”), is made by Barclays Bank PLC, in its capacity as Collateral Agent (the “Agent”), in favor of each grantor party identified on the signature page hereto (each a “Grantor”).

WHEREAS, pursuant to that certain First Lien Guarantee and Collateral Agreement, dated as of May 23, 2014, by and among the Agent and certain other parties thereto, as supplemented by that certain Assumption Agreement, dated as of February 26, 2015, by and among the Agent, the Grantors and certain other parties party thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered an IP Security Agreement, dated as of February 26, 2015 (the “Intellectual Property Security Agreement”), for recordation with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on March 2, 2015 at Reel/Frame 035115/0394, recorded with the United States Patent and Trademark Office on March 2, 2015 at Reel/Frame 5469/0524 and filed with the United States Copyright Office on March 3, 2015;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreement, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Patents, including the patents and patent applications set forth in Schedule A attached hereto, Copyrights , including the copyright registrations and applications set forth in Schedule B attached hereto and the Trademarks, including the trademark registrations and applications set forth in Schedule C attached hereto, arising under the Security Agreement and the Intellectual Property Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Patents, Copyrights or the Trademarks under the Intellectual Property Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the applicable Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
