**INTELLECTUAL PROPERTY ASSIGNMENT**

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration described in the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Seller hereby sells, conveys, assigns, and transfers to Buyer all of Seller’s rights, titles and interests in the United States and in all foreign countries, to the extent Seller is the owner of such foreign rights, in and to the Exclusive Business IP, and all licenses or sublicenses with respect to any Exclusive Business IP identified on Exhibit A, together with the goodwill of the business symbolized by each of them, and any and all registrations thereof, as well as all rights to damages or profits, due or accrued, arising out of pastime infringement of any of them or injury to said goodwill and the right to sue for and recover the same in Buyer’s own name.

Capitalized terms used but not defined herein shall have the meanings given to such terms in the Asset Purchase Agreement.
