CONFIRMATORY TRADEMARK CONTRIBUTION AGREEMENT**

THIS CONFIRMATORY TRADEMARK CONTRIBUTION AGREEMENT (this "Confirmatory Contribution Agreement") is made and entered into as of June 1, 2016 ("Effective Date"), by and between **United States Steel Corporation**, a Delaware corporation ("Transferor"), and **U. S. Steel Tubular Products, Inc.**, a Delaware corporation and wholly-owned subsidiary of Transferor ("Transferee").

WHEREAS, Transferor and Transferee are parties to that certain Master Agreement entered into on March 1, 2016 (the "Master Agreement");

WHEREAS, pursuant to the Master Agreement, Transferor has contributed to Transferee all of Transferor's right, title and interest in, to and under the trademarks set forth on Schedule A hereof, together with the goodwill of the business associated therewith (collectively, the "Marks");

WHEREAS, Transferee has acquired from Transferor all of Transferor's right, title and interest to the Marks; and

WHEREAS, this Confirmatory Contribution Agreement is entered into by the parties in order to act as a record of such contribution under the Master Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, pursuant to the Master Agreement, Transferor has contributed, conveyed, assigned, transferred and delivered to Transferee its entire right, title and interest in and to the Marks and Transferee has accepted all risk of loss with respect to the Marks. Transferor hereby requests the United States Commissioner of Patents and Trademarks to record Transferee as the acquirer and owner of the Marks.
