RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Skydd subsequently merged with the Company, pursuant to that certain Certificate of Merger, dated as of July 31, 2014 and recorded with the USPTO on August 27, 2014 at Reel: 005352, Frame: 0775; and

WHEREAS, Secured Party desires to release its security interest in the Trademarks;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party does hereby fully and finally release and relinquish all interest granted to Secured Party pursuant to the Security Agreement, including but not limited to, all of Secured Party's security interests, rights, title, and interest in the names, trademarks, and registrations identified in Schedule 1 hereto, and the goodwill of the business symbolized by and associated therewith.

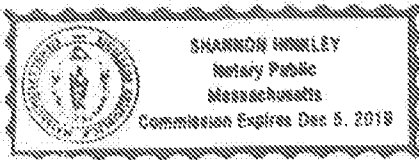
