RELEASE AND TERMINATION OF TRADEMARK SECURITY INTEREST

This RELEASE AND TERMINATION OF TRADEMARK SECURITY INTEREST (this "Release and Termination") is executed as of August 12 2016, by THE TORONTO-DOMINION BANK, a chartered bank under the Bank Act (Canada), acting as collateral agent (the "Agent") for the benefit of the Credit Agreement Lenders (as defined in the Trademark Security Agreement) and for the holders of the Notes (as defined in the Trademark Security Agreement) (the "Agent"), with reference hereby made to that certain Trademark Security Agreement dated as of March 9, 2012 (the "Trademark Security Agreement"), by APPLGATE LIVESTOCK EQUIPMENT, INC., an Indiana corporation (the "Grantor"), in favor of the Agent.

WHEREAS, the Grantor has requested that the Agent release the lien and security interest granted to it in the right, title and interest in and to the trademark of the Grantor, together with the goodwill of the business symbolized thereby, set forth on Schedule A attached hereto (the "Trademark"), pursuant to the Trademark Security Agreement.

For good and valuable consideration, the receipt of which is hereby acknowledged:



The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable United States government officer record this Release and Termination.
