TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (the "**Agreement**") is made as of August [16], 2016 by Camden Partners Strategic III, LLC ("**Grantee**") in favor of New Horizons Education Corporation (the "**Grantor**").

WHEREAS, the Grantor granted a security interest in certain intellectual property and related rights to Grantee pursuant to that certain Trademark Security Agreement, dated as of July 11, 2006, by Grantor in favor of Grantee (the "**Trademark Security Agreement**");

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at reel 003351, frame 0628 on July 20, 2006;

WHEREAS, Grantor has requested that Grantee terminate and release its interest in Grantor's trademarks (the "**Trademarks**") identified in the Trademark Security Agreement including, without limitation, those trademarks identified in Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantee hereby:

1. terminates and releases any and all security interests of Grantee in Grantor's: (i) Trademarks and any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, any of the Trademarks, and (ii) all products and proceeds of any of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any such Trademarks, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Grantee with respect to the Trademarks pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
