RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Security Interest (“Release”) is made effective as of August 15, 2016, by NEWSTAR FINANCIAL, INC., as administrative agent for the benefit of the secured parties (hereinafter, the “Secured Party”) to The Copernicus Group, Inc.. (the “Debtor”), as follows:

WHEREAS, on May 31, 2012, the Secured Party and Debtor entered into an Intellectual Property Security Agreement (the “2012 Security Agreement”), and the 2012 Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on June 6, 2012 at Reel/Frame 4796/0249.

WHEREAS, pursuant to the 2012 Security Agreement, the Debtor granted to the Secured Party, among other collateral, a security interest in all the Debtor’s right, title and interest in all of the Debtor’s trademarks and all rights in and to said trademarks, including those referred to on Schedule A hereto, and all other trademark collateral described in the 2012 Security Agreement (collectively, the “Trademark Collateral”); and

WHEREAS, the Secured Party desires to terminate the security interests, and execute and deliver to the Debtor all deeds, assignments and other instruments as may be reasonably necessary to properly release the security interests relating to the Trademark Collateral, at Debtor’s expense.


WHEREAS, Debtor has no outstanding obligations to the Secured Party under the terms of the 2012 Security Agreement, Debtor agrees to release its security interest in the Trademark Collateral.

NOW THEREFORE, the Secured Party agrees that it terminates and releases its security interest in the Trademark Collateral and reassigns to Debtor, without representation or warranty of any kind, nature or description, all right, title and interest of the Secured Party in and to the Trademark Collateral.
