TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 16, 2016, by BANK OF AMERICA, N.A., ("BofA") for itself and as successor to LaSalle Bank National Association ("LaSalle Bank"; collectively referred to herein as the "Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Agreements (as defined below), and the Financing Agreements (as defined in the LaSalle Bank Trademark Agreement), as applicable.

WITNESSETH:

WHEREAS, FORSYTHE TECHNOLOGY, INC., an Illinois corporation ("Forsythe Technology") and FORSYTHE/MCARTHUR ASSOCIATES, INC., an Illinois corporation ("Forsythe McArthur"; together with Forsythe Technology, the "Grantors", and each individually, a "Grantor"), BofA (as successor to LaSalle Bank), and the other parties signatory thereto are parties to that certain Trademark Security Agreement, dated as of March 31, 2006 (as amended, amended and restated, joined, supplemented or otherwise modified from time to time, the "LaSalle Bank Trademark Agreement") pursuant to which Grantors granted a security interest to BofA (as successor to LaSalle Bank) in certain Trademarks (as defined in the LaSalle Bank Trademark Agreement) as security for certain obligations owing by Grantors to BofA (as successor to LaSalle Bank), including, without limitation, certain Trademarks set forth on Schedule 1 hereto;

WHEREAS, Forsythe Technology, BofA, and the other parties signatory thereto, are parties to that certain Trademark Security Agreement dated on or before December 17, 2009 (as amended, amended and restated, joined, supplemented or otherwise modified from time to time, the "BofA Trademark Agreement"; together with the LaSalle Bank Trademark Agreement, the "Trademark Agreements") pursuant to which Forsythe Technology granted a security interest to BofA in certain Trademarks (as defined in the BofA Trademark Agreement) as security for certain obligations owing by Forsythe Technology to BofA, including, without limitation, certain Trademarks set forth on Schedule 1 hereto;

WHEREAS, the LaSalle Trademark Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on April 3, 2007, at Reel 3515, Frame 0047 and the BofA Trademark Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 17, 2009, at Reel 4116, Frame 0783;

WHEREAS, Grantors have satisfied the terms of the Trademark Agreements and Financing Agreements and have requested that Collateral Agent release its security interest in the Trademarks and reassign any and all rights in the same to Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby (i) terminates the Trademark Agreements, Financing Agreements and any and all documents related thereto and any and all rights it may have under the Trademark Agreements, Financing Documents or any documents related thereto and (ii) terminates, cancels, releases and discharges its lien on and security interest in all of Grantors' right, title and interest in, to the Trademarks described on Schedule 1 hereto.


2. Collateral Agent hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in, to and under the Trademarks of such Grantor. Collateral Agent authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence release and termination of its rights under each of the Loan Documents (as defined in the Credit Agreement) with respect to the Trademarks set forth on Schedule 1 hereto.

3. This Trademark Release and Reassignment shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
