**BILL OF SALE**

**THIS BILL OF SALE** (the "Bill Of Sale"), effective as of the 2<sup>nd</sup> day of July, 2015, from **SOUTHEAST FOOD SYSTEMS, INC.** (hereinafter "Seller") and **KIOSK FOODS, LLC** (hereinafter "Purchaser"). **WITNESSETH:**

**Section 2.** Nothing in this Bill of sale, express or implied, is intended or shall be construed to confer upon or give to, any person, firm or corporation other than Purchaser and Seller and their respective successors and assigns, any remedy or claim under or by reason of this Bill of Sale or any term, covenant or condition hereof, and all the terms, covenants and conditions, promises and agreements contained in this Bill of Sale shall be for the sole and exclusive benefit of Purchaser and Seller and their respective successors and assigns.

**Section 3.** Seller for itself, its successors and assigns hereby covenants and agrees that, any time and from time to time forthwith upon the written request of Purchaser, Seller will, at Purchaser's expense, do, execute, acknowledge and deliver or cause to be done, executed, acknowledged or delivered, all and every such further acts, deeds, assignments, transfers, conveyances, powers of attorney, and assurances as may be reasonably required by Purchaser in order to sell, assign, transfer, and convey to, and vest in, Purchaser, its successors and assigns, or to aid and assist Purchaser in reducing to possession any or all of the Assets assigned or to be assigned to Purchaser.

**Section 4.** This Bill of Sale is executed by, and shall be binding upon, Seller, their successors and assigns, for the uses and purposes above set forth and referred to, as of the effective date thereof.

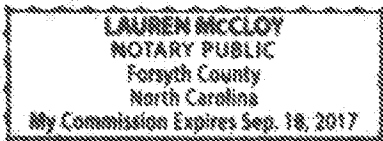

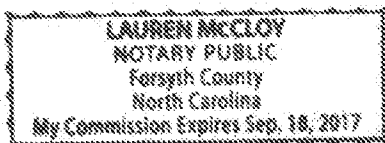
