RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS (this “Release”) is made as of August 16, 2016 (the “Effective Date”) by and between Leslie’s Poolmart, Inc. (“Poolmart”), Ram Chemical & Supply, Inc. (“Ram” and together with Poolmart, the “Grantors”) and Bank of America, N.A., in its capacity as administrative agent under the Credit Agreement (as defined herein) for the benefit of itself and the Lenders (as defined herein), and its successors, assigns and other legal representatives (“Grantee”). Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Credit Agreement.

WHEREAS, pursuant to the terms and conditions of that certain (i) Trademark Security Agreement, dated as of October 16, 2012 (as amended, restated or otherwise modified as of the date hereof, the “Poolmart Trademark Security Agreement”), by and among the Poolmart and Grantee, (ii) Trademark Security Agreement, dated as of February 13, 2013 (as amended, restated or otherwise modified as of the date hereof, the “Ram Trademark Security Agreement Joinder”), by and among the Ram and Grantee and (iii) Patent Security Agreement, dated as of October 16, 2012 (as amended, restated or otherwise modified as of the date hereof, the “Patent Security Agreement” and, together with the Poolmart Trademark Security Agreement and Ram Trademark Security Agreement, the “Intellectual Property Security Agreements”), by and among the Poolmart and Grantee, Grantors pledged, assigned and granted to Grantee a continuing security interest in and lien on and right of set-off against all of its right, title and interest in and to its IP Collateral (as defined herein), including without limitation the trademark registrations and applications set forth on Schedule A hereto and the goodwill associated therewith (collectively, the “Trademark Collateral”) and the patent registrations and applications set forth on Schedule B hereto (collectively, the “Patent Collateral” and together with the Trademark Collateral, the “IP Collateral”), in order to secure obligations owed by Grantors under the Credit Agreement dated as of October 16, 2012 (the “Credit Agreement”) by and among the Grantors, the financial institutions named therein, as lenders (the “Lenders”), and the Grantee, as Administrative Agent and a Lender;

WHEREAS, Grantors and Grantee entered into the Intellectual Property Security Agreements pursuant to the terms and conditions of the Credit Agreement;

WHEREAS, the Intellectual Property Security Agreements were recorded with the United States Patent and Trademark Office (“PTO”) at Reel 4885, Frame 0030 on October 19, 2012 and at Reel 4967, Frame 0386 on February 21, 2013 (the Trademark Collateral) and Reel 029157, Frame 0024 (the Patent Collateral) on October 19, 2012; and

WHEREAS, as of the date hereof, Grantors have satisfied all Obligations (as defined in the Credit Agreement) (other than any inchoate Obligations which have not been asserted, including any indemnification Obligations which survive the

termination of the Credit Agreement) under the Loan Documents, including, without limitation, the obligations of the Lenders to provide credit thereunder, have been terminated (other than the provisions of the Loan Documents which, by their terms, survive the termination or cancellation of the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Intellectual Property Security Agreements, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the IP Collateral.

If and to the extent Grantee has acquired any right, title or interest to any of the IP Collateral, it hereby assigns and transfers such rights, title or interest to Grantors.

Grantee shall take all further actions, reasonably acceptable to Grantee, and provide to Grantors and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantors, each at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
