TRADEMARK RELEASE

This Trademark Release is made and effective as of August 4, 2016, by **U.S. BANK NATIONAL ASSOCIATION**, in its capacity as collateral trustee for itself and the Parity Lien Secured Parties (in such capacity, the "Parity Collateral Trustee") under the Collateral Trust Agreement, dated as of May 12, 2014 (as amended, restated, amended and restated, replaced, supplemented or otherwise modified from time to time, the "Collateral Trust Agreement"), among the Grantor, certain of its affiliates, the Trustee (as defined therein), the Priority Collateral Trustee, the Administrative Agent and the Parity Collateral Trustee, in favor of **FORESTAR PETROLEUM CORPORATION**, a Delaware corporation ("Grantor").

WHEREAS, Grantor executed in favor of the Parity Collateral that certain Intellectual Property Security Agreement, dated as of May 12, 2014 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), by Grantor in favor of the Parity Collateral Trustee;

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on May 12, 2014 at Reel 5278, Frame 0694 against the Trademarks set forth on Schedule A thereto;

WHEREAS, the lien and security interest of the Parity Collateral Trustee has been released;

WHEREAS, the Parity Collateral Trustee has agreed to and confirms its release of the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademarks and reassigns the same to Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Parity Collateral Trustee hereby fully and finally terminates the Trademark Security Agreement and releases its security interest in all of the Grantor's right, title and interest in, to and under the Trademarks, including, without limitation, those items listed on Schedule A hereto.


2. The Parity Collateral Trustee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Parity Collateral Trustee, all of Parity Collateral Trustee's right, title and interest (if any) in the Trademarks.

3. This Trademark Release is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to conflict of laws principles.
