TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "<u>Agreement</u>"), dated as of July 12, 2016 (the "<u>Effective Date</u>"), is entered into by Starboard Collection, LLC f/k/a Everyday Sailing, LLC, a Vermont limited liability company ("<u>Assignor</u>"), in favor of Alice Ink Incorporated, a Florida corporation ("<u>Assignee</u>"). Each of Assignor and Assignee is sometimes referred to in this Agreement as a "<u>Party</u>". Assignor and Assignee are sometimes referred to in this Agreement as, together, the "Parties".

RECITALS:

- A. Assignor is the owner of the US Trademark Reg. No. 4,593,532 "Starboard Collection" (the "Starboard Trademark").
- B. Assignor has agreed to execute and deliver this Agreement for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions.

NOW, THEREFORE, in consideration of \$1.00, and other good and valuable consideration, the receipt and adequacy of which consideration are hereby conclusively acknowledged, Assignor, intending to be legally bound, hereby agrees as follows:

- 1. <u>Assignment.</u> Assignor hereby irrevocably conveys, transfers and assigns to Assignee (including all of Assignee's successors, assigns, heirs and administrators) all of Assignor's right, title and interest in and to the following (collectively, the "<u>Assigned Trademark</u>"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademark:
 - (a) the Starboard Trademark and all registrations, issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals of, or which may evolve from, the Starboard Trademark;
 - (b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
 - (c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
 - (d) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the Effective Date, including, without limitation, all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

For the avoidance of doubt, and without limiting the foregoing, Assignor hereby irrevocably conveys, transfers and assigns to Assignee (including all of Assignee's successors, assigns, heirs and administrators) all of Assignor's right, title and interest in and to the Starboard Trademark in all foreign countries, and all applications for the Starboard Trademark in foreign countries and all registrations, issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and

renewals of, or which may evolve from, the Starboard Trademark, including, without limitation, the right to claim International Convention priority.

- 2. <u>Recordation</u>. Assignor hereby authorizes the Commissioner of Trademarks in the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions to record and register this Agreement upon request of Assignee.
- 3. <u>Additional Acts by Assignor</u>. From time to time after the Effective Date, Assignor will execute and deliver to Assignee such additional documents, instruments, transfers, conveyances, assignments and assurances, take such further actions and do all matters and things as may be convenient or necessary to convey and transfer full right, title and interest to Assignee, vest in Assignee, and place Assignee in legal and actual possession of, the Assigned Trademark.


