TRADEMARK ASSIGNMENT AGREEMENT


WHEREAS, Assignor and Assignee desire to memorialize the transfer of Assignor’s trademarks and related rights to Assignee.

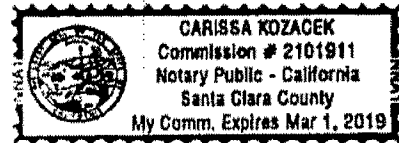
