CONFIRMATORY TRADEMARK ASSIGNMENT

This CONFIRMATORY TRADEMARK ASSIGNMENT ("Assignment") is executed this 16th day of August, 2016, by and between Alkermes Pharma Ireland Limited, a private limited company incorporated in Ireland ("Assignor"), and Recro Gainesville LLC, a Massachusetts limited liability company ("Assignee"), who is successor in interest to DV Technology LLC, a Delaware limited liability company ("Assignee's Predecessor").

WHEREAS, prior to assigning and licensing any of its rights to Assignee's Predecessor and Assignee, Assignor owned the entire right, title and interest in and to the trademarks identified on Schedule A (collectively, the "Marks"), together with the goodwill of the business symbolized thereby and associated herewith;

WHEREAS, on April 10, 2015, pursuant to that certain Asset Transfer and License Agreement between Assignor and Assignee's Predecessor (the "April 2015 Assignment and License"), Assignor did assign to Assignee's Predecessor, *inter alia*, all right, title and interest in and to certain of the Marks as they related to Assignor's business (the "Assigned Business"), together with the goodwill of the Assigned Business symbolized thereby and associated therewith;

WHEREAS, Assignee's Predecessor subsequently changed its name to Recro Technology LLC and further merged with and into Assignee;

WHEREAS, on December 23, 2015, Assignor and Assignee amended the April 2015 Assignment to, *inter alia*, further assign to Assignee all right, title and interest in and to the other Marks as they related to the Assigned Business, together with the goodwill of the Assigned Business symbolized thereby and associated therewith;

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor hereby acknowledges that it did, on April 10, 2015 and December 23, 2015, sell, assign, transfer and set over to Assignee, its predecessors, successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks as they related to the Assigned Business, including the trademarks identified in Schedule A, together with the goodwill of the Assigned Business symbolized thereby and associated therewith.
