**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“**Release**”) dated August [22], 2016 is made by Great Southern Bank (“**GSB**”), in favor of Nature’s Bakery, LLC, as successor-in-interest to Bella Four Bakery, Inc. (“**NB**”).

In accordance with the foregoing, for good and valuable consideration, the receipt of which is hereby acknowledged, GSB, on behalf of itself and its successors and assigns, does hereby release its security interest in all of NB’s intellectual property and discharges, quitclaims and relinquishes unto NB and any party that has rights to such intellectual property (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to such intellectual property, including U.S. Registered Trademark Nos. 3917217, 4119643 and 3917078.

(3) This Release shall be governed by and construed in accordance with the laws of the State of Missouri, without giving effect to any choice or conflict of law provision or rule.
