**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (the "Trademark Assignment") is made as of August 16, 2016 (the "Effective Date"), by **CornellCookson, Inc.**, a Delaware corporation having its principal place of business at 24 Elmwood Road, Mountain Top, Pennsylvania 18707 (the "Assignor"), in favor of **CIW Enterprises, Inc.**, a Delaware corporation having its principal place of business at 24 Elmwood Road, Mountain Top, Pennsylvania 18707 (the "Assignee").

A. Assignor owns the federal registration for the mark TRANZFORM (Reg. No. 3137103) (the "Mark") and the goodwill of the business associated with the Mark, and desires to assign all right, title, and interest in and to the Mark along with the associated goodwill to the Assignee.

B. Assignee wishes to obtain the Mark, including all right, title, and interest in and to the Mark and the associated goodwill, from Assignor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, and intending to be legally bound, the parties hereto agree as follows:

1. Assignor assigns, transfers, and sets over to Assignee all right, title, and interest in and to the Mark, the goodwill of the business associated with the Mark, and the right to sue for and receive all damages from past infringements of the Mark, the same to be held and enjoyed by Assignee, its successors, assigns, and other legal representatives.

2. Assignor authorizes and requests that the Commissioner of Patents and Trademarks of the United States record Assignee as the owner of the federal registrations for the mark TRANZFORM (Reg. No. 3137103). Assignor further agrees to execute such additional documents as may be reasonably requested by Assignee to evidence or perfect the assignment of the Mark to Assignee.

3. This Trademark Assignment may be executed in counterparts, each of which shall be deemed to be an original, but all of which together shall be deemed to be one and the same. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment
