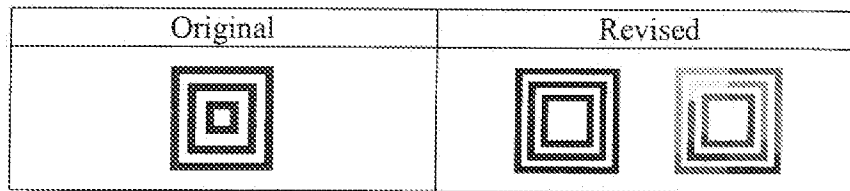




B. Assignee desires to acquire all right, title and interest in and to the Mark.


